#### Jakarta EE 11 Update

- Reference Information
  - The following reflects the release plan of record
    - Jakarta EE 11 Release Plan
  - Tracking <u>spreadsheet</u> of specifications progressing through the <u>JESP</u> version <u>lifecycle</u>.

- August 27 update
  - The following ETA was provided for completion of the Platform TCK refactoring work at the last <u>Jakarta EE Platform TCK Call</u>:
    - <refactoring-ee-11-all-done-date> is: 2024-11-27.
    - <percentage-confidence-in-that-date> is: 5%. 2024-08-27: 19%
  - In effect, as of last week, we do not have a credible Jakarta EE 11 plan at this time
  - The Steering Committee needs to review the situation and help define a credible EE11 plan and roadmap.
  - Discussion
    - Goal of Platform TCK refactoring:
      - Make the TCK easier to work with, and therefore make Jakarta EE more attractive for spec development
      - Eliminate dependence on obsolete TCK technology
    - Each row in the **porting** section of the backlog chart <u>https://github.com/orgs/jakartaee/projects/12/views/1</u> reflects an test(s) that needs to be refactored. There are 31 rows in the **Porting** section in this chart.
    - A framework for refactoring existing tests has been created in the past 2 weeks using OpenRewrite.
    - As of last week, 5% of the rows (I assume that means 2 rows) had been refactored using this framework. This is where the "5% confidence" estimate came from. The completion date of November 27 was somewhat arbitrary.
    - As of today,
      - 6 rows (19%) have been refactored
      - 4 rows are in "done" status (this was not discussed in the meeting, I assume a row that is "done" does not need to be refactored. This assumption should be validated.)
    - $\circ$   $\;$  Options with respect to Platform TCK work
      - Plan of record work TCK refactoring to completion (schedule currently does not meet Working Group requirements)
      - Possible option "scope back" to subset of specifications, rely on EE 10 TCK tests for "unchanged" specifications
      - Do not have a well-defined plan that meets Working Group requirements at this time - strongly prefer plan for TCK completion and full EE 11 delivery ASAP, and prior to JakartaOne Livestream
    - Next steps for "get well" planning
      - This state of the plan will be discussed at the next TCK meeting
      - Request update at the next Steering Committee meeting
- September 10 Update
  - Preliminary notes:

- The last two meetings of the Platform TCK have been productive and have demonstrated substantial progress
- As of Sept 8 the following is a summary status of the refactoring work backlog captured at <u>https://github.com/orgs/jakartaee/projects/12/views/1</u> (See the "Refactoring (was Porting)" section - rows 34-64)
  - Total number of rows 31
    - "Done" 6
    - "In review" 4
    - "In progress" 15
    - "Ready to Assign" 6
  - Refactoring framework has proven effective
  - Most rows "in progress" are progressing well
  - Rows "to be assigned" include a very small number of tests
  - Consensus during has been to prioritize completion of the Plan of Record and complete refactoring

## • Discussion notes: Ed Burns, Scott Marlow

- Platform TCK Calls are held weekly. Will Lyons has attended the previous two meetings. There is now a Plan A and a Plan B
  - Plan A is, get everything done, possibly with a few short-cuts
  - Plan B is a hybrid run newly refactored TCKs along with some legacy JavaText TCKs.
  - Due for check-in before the next steering committee meeting to ensure that Plan A is still the most effective/viable approach.
  - Always mindful of target date and confidence number: Currently Date is Nov. 27 with 50% confidence. These two indicators are tracked at each TCK weekly meeting (the next one will be tomorrow).
    - Discussion about how the confidence value is derived. It includes number of tests, number of tests passing/failing. Not yet running against GlassFish 8. (GlassFish 8 is anticipated to be the initial compatible implementation for EE 11)
- Looked at the TCK review board. Discussed actions that need to occur: Complete the GlassFish runner (#1434), All passing test counts need to be converted to GlassFish results. Someone will need to determine what 'close enough' means, to declare the test is showing that the result is certifiable as compatible.
- It was cautioned that GlassFish related work should be discussed with the GlassFish committer team – either the -dev list or, the Platform committer team (meets weekly on Tuesday mornings). Also, discussed at the TCK committer team meetings (Wed. at 8AM PDT). (We want to avoid mis-set goals/dates/ect)
- Ed Bratt opened a discussion about the dates and announcements

- Nov. 27th is the target for TCK complete. This would be the earliest that ballots could start. Ballot requirements include: TCK w/Docs, Compatible Implementation with CCR, and all Ballot materials (Specifications, Procedural requirements, etc.)
  - After the TCK complete would need minimum 1, maximum 2 weeks for the ballots to complete
  - This implies release would be mid Dec.
- Marketing would need a firm go/no-go by the next to last week in Nov.
- JakartaONE is Dec. 3.
  - Most desirable message would be: Jakarta EE 11 is released, go get it
  - Good message might be: Could also message that Jakarta EE 11 is in ballot and will be released on X date.
  - Reality may be: we are still working to deliver Jakarta EE 11
- There is no mandatory requirement that release/marketing plan begin immediately upon the release. E.g. a release might complete mid-Dec and ballots completed prior to year-end. Marketing campaign could start in Jan. (i.e. there's no requirement that Marketing campaign start the instant the release is completed.)
- $\circ$   $\,$  We would like to preserve the two year cadence for releases
- Ed Burns will challenge the GlassFish and TCK teams for a release the week of Nov. 20th, outside date the 25th and return to this committee with the feedback.
- [no updates] The Marketing committee requires 3 weeks notice to be able to prepare properly for the launch of release-related marketing activities.
  - August 13 Update
    - Marketing material is staged as best as possible awaiting final release date.
